- -Mike had passed out copies of the proposed budget for 2023, which also had the District's expenditures from 2022
- -Mike had also mentioned that a budget item was for milage reimbursement for GSRs that attend events outside of District 12; recorded milage can be submitted to Mike for reimbursement of \$0.20 per mile
- -Mike said he had upped the budget for the picnic for 2023 since we were over budget in 2022
- -Mentioned how money for H & I is not factored in the budget, but we can adjust for that if the District makes another contribution to H & I in 2023
- -Brian had made a motion to adopt the budget and it was seconded by Jared and budget passed and the budget is attached to the email
- -It had also been mentioned how the budget is not set in stone and adjustments can be made through a Group Conscience vote
- -Mike had also reported the following numbers for the month of January:

- -Dom had mentioned how District emails are still going out via Mail Chimp and how there had been 3 emails sent out, 2 Meeting Reminders for the Business Meeting & one about an event announcement, the week of the Business Meeting
- -Dom said if you are not getting the District emails to talk with him and he will get it taken care of by looking into it

Registrar: Lenore (d12registrar)gmail.com):

- -Lenore had reminded GSRs to please sign in on the sign in sheets
- -She had asked GSRs to confirm the information on the sign in sheets is correct and how items on the sign in sheets that are in yellow means there is some information that is needed
- -Lenore had also stated that if GSRs have not gotten their GSR packets to talk with her so she can look into the issue

#### **Old Business**

- \*7<sup>th</sup> Tradition
- -Motion to restart passing basket at District Meetings had been tabled at January Business Meeting and was revisited at this Business Meeting
- -David C. had restated what the motion had been and discussed why it is important

District Discussion on this item:

-Brian had asked for clarification if the District Business Meeting is considered a group since the 7<sup>th</sup> Tradition states, "Every A.A group should be..." Bob had explained how the 7<sup>th</sup> Tradition

basket had started getting passed at the Business Meeting to purchase refreshments and that at Area Meetings there is a basket by refreshments, but not passed around as 7<sup>th</sup> Tradition

- -Jared had asked about how we are classified as a non-profit and if there is an excess of funds it could change the reporting of finances; Bob had stated the number of funds would have to be over \$50,000 and this had never happened
- -Another GSR had asked if the \$22,000+ the District has had come from 7<sup>th</sup> Tradition; Bob had some of it probably & Dom said some of it may have carried over from District Meetings from pre-Covid
- -Another GSR had asked about how people could choose to not put anything in the basket if it was passed around for 7<sup>th</sup> Tradition; Bob had said yes, it was an optional thing
- -Lisa had asked to make a friendly amendment to the motion, which was to place a basket next to refreshments for people to contribute if they want to; David C. had stated this would then make it not a 7<sup>th</sup> Tradition basket and chose not to make that amendment
- -Walt had asked if we needed to collect enough with 7<sup>th</sup> Tradition to cover all costs (rent, refreshments, etc.); Bob explained how even when we had been passing the 7<sup>th</sup> Tradition all costs were never covered
- -Vickie had asked where money is coming from to cover rent & refreshments now & said her group passes the basket to cover all their costs; Bob explained how money is contributed to the District from AA Groups & through online contributions
- -Lance had stated that we are supporting ourselves already because our AA Groups are already sending money to the District
- -Topher had said that the payment is getting to be here and that it didn't make sense to keep discussing buying refreshments and that passing the basket gives those that want to contribute a chance to do so and those that don't want to can choose to not put anything in the basket
- -Motion was voted on, 44 in favor and 5 opposed; minority chose not to say anything and the motion to restart passing the 7<sup>th</sup> Tradition basket passed

## \*Ranking of District Event Ideas

- -Last month GSRs were asked to rank the suggested events that had come out of December's Business Meeting and the rankings were as follows (only number 1 will take place at this point):
- 1. Sponsorship Workshop
- 2. Summer Beach Party
- 3. Comedy Show
- 4. Alcothon with food

- -Regarding the Sponsorship Workshop , Beth had said the Jim is trying to secure a location, which is the church in Laguna Woods where the Do It Sober Group has their meetings & tentative date is May 13
- -Jared had asked about the idea of using excess District funds to make literature cheaper and Bob had said that could be an agenda item that can be discussed and voted on after the logistics are looked at and what the cost may look like
- \*Pre-conference Boot Camp
- -Bob said that The Preconference Boot Camp will be held at Walton Middle School
- -Bob had explained how 4 GSRs will give a 5 minute presentation on one agenda item each from the General Service Conference agenda items at the Pre-conference Boot Camp
- -GSRs would study the background material for the agenda item they would be presenting to give understanding of where the agenda item(s) came from
- -The GSRs would only be presenting the agenda items not expressing opinion on it & would need to submit their report in writing so it can be accessed by other GSRs; the purpose of Pre-conference Boot Camp is to help GSRs be prepared to present agenda items to their groups
- -Bob had sign up sheets for those interested in volunteering; volunteers to present the agenda items & people to set up and clean up are needed for this event
